# The Air Navigation (Restriction of Flying) (Royal Air Force Coningsby) (No. 2) Regulations 2021

 Made
 2nd July 2021

 Coming into force
 23rd July 2021

The Secretary of State has decided that it is in the public interest to restrict flying in the vicinity of RAF Coningsby, Lincolnshire, by reason of the intended holding of a flying display which is scheduled to take place there.

The Secretary of State makes the following Regulations in exercise of the powers conferred by article 239 of the Air Navigation Order 2016(a).

### Citation and commencement

**1.** These Regulations may be cited as the Air Navigation (Restriction of Flying) (Royal Air Force Coningsby) (No. 2) Regulations 2021 and come into force on 23rd July 2021.

## Interpretation

**2.** In regulation 3(1) the times referred to are Co-ordinated Universal Time(**b**).

## Restricted airspace

- **3.**—(1) Subject to paragraph (2), between 0800 hours and 1600 hours on 23rd July 2021 no aircraft is to fly below 3,000 feet above mean sea level within the area bounded by a circle having a radius of 3 nautical miles whose centre is at 530557N 0001008W.
  - (2) Paragraph (1) does not apply to any aircraft—
    - (a) flying in accordance with a permission issued by the Royal Air Force Coningsby Families Day flying display director, or
    - (b) making an approach to, or departing from, Royal Air Force Coningsby under the control of the air traffic control unit at Royal Air Force Coningsby.

#### Revocation

**4.** The Air Navigation (Restriction of Flying) (Royal Air Force Coningsby) Regulations 2021(c) are revoked.

### **EXPLANATORY NOTE**

(This note is not part of the Regulations)

These Regulations impose restrictions on flying in the vicinity of Royal Air Force Coningsby, Lincolnshire, during an air display that is scheduled to take place there on 23rd July 2021. A large number of aircraft will be involved in high energy manoeuvres during the display and therefore the Civil Aviation Authority and the Department for Transport agree that flying should be restricted in the vicinity of the event for reasons of public safety.

These Regulations also revoke the Air Navigation (Restriction of Flying) (Royal Air Force Coningsby) Regulations 2021 (S.I. 2021/575) due to a change in the scheduled date of the Royal Air Force Coningsby Families Day event.

The times mentioned in regulation 3(1) are Co-ordinated Universal Time (UTC) which is one hour behind British Summer Time (BST).

In relation to the permission mentioned in regulation 3(2)(a), the Royal Air Force Coningsby Families Day flying display director may be contacted as notified.

Full details of this Statutory Instrument will be promulgated by Notice to Aviation (NOTAM).
