# The Air Navigation (Restriction of Flying) (Tottenham Hotspur Football Stadium) Regulations 2022

Made - - - - 5th September 2022

Coming into force - - 2nd October 2022

The Secretary of State has decided that it is in the public interest to restrict the flying of unmanned aircraft in the area specified in regulation 3(1) by reason of the intended gathering of a large number of persons at the NFL Football Game which is scheduled to take place there.

The Secretary of State makes the following Regulations in exercise of the powers conferred by article 239 of the Air Navigation Order 2016(a).

#### Citation and commencement

**1.** These Regulations may be cited as the Air Navigation (Restriction of Flying) (Tottenham Hotspur Football Stadium) Regulations 2022 and they come into force on 2nd October 2022.

### Interpretation

**2.** In regulation 3(1) the times referred to are Co-ordinated Universal Time(**b**).

## Restricted airspace

- **3.**—(1) Subject to paragraph (2), between 1200 hours and 1900 hours on 2nd October 2022 no unmanned aircraft is to fly below 1,200 feet above mean sea level within the area bounded by a circle having a radius of 1.5 nautical mile whose centre is at 513619N 0000407W.
- (2) Paragraph (1) does not apply to any unmanned aircraft operating with the permission of the Metropolitan Police.

## **EXPLANATORY NOTE**

(This note is not part of the Regulations)

These Regulations impose restrictions on the flying of unmanned aircraft in the vicinity of Tottenham Hotspur Football Stadium, London during an NFL football game that is scheduled to take place there on 2nd October 2022. A large number of spectators will attend the game therefore the Metropolitan Police considers that unmanned aircraft flying should be restricted in the vicinity of the Stadium for reasons of public safety and security. The restrictions have been agreed by the Civil Aviation Authority and the Department for Transport.

The times mentioned in regulation 3(1) are Co-ordinated Universal Time (UTC) which is one hour behind British Summer Time (BST).

In relation to the permission mentioned in regulation 3(2), the Metropolitan Police may be contacted as notified.

Full details of this Statutory Instrument will be promulgated by Notice to Aviation (NOTAM).
