The Air Navigation (Restriction of Flying) (His Majesty the King's Birthday Flypast) (No. 2) Regulations 2023

Made - - - - Coming into force-

25th May 2023 17th June 2023

The Secretary of State has decided that it is necessary in the public interest to restrict flying in the area specified in regulation 3 by reason of the intended holding there of a large formation flypast of aircraft to commemorate the birthday of His Majesty the King.

The Secretary of State makes the following Regulations in exercise of the powers conferred by article 239 of the Air Navigation Order $2016(\mathbf{a})$.

Citation and commencement

1. These Regulations may be cited as the Air Navigation (Restriction of Flying) (His Majesty the King's Birthday Flypast) (No. 2) Regulations 2023 and they come into force on 17th June 2023.

Interpretation

2.—(1) In these Regulations "Flight Level" has the same meaning as defined in Schedule 1 to the Air Navigation Order 2016,

(2) In regulation 3 the times referred to are Co-ordinated Universal Time(**b**).

Restricted airspace

3.—(1) Subject to paragraphs (10) and (15), between 1045 hours and 1230 hours on 17th June 2023 no aircraft is to fly below Flight Level 175 within the area bounded by straight lines joining successively the following points—

- (a) 533600N 0001100E,
- (b) 533600N 0004300E,
- (c) 532700N 0023000E,
- (d) 525500N 0030900E,
- (e) 521322N 0023430E,
- (f) 521141N 0022435E,
- (g) 521033N 0015518E,

(4) Subject to paragraphs (10) and (15), between 1115 hours and 1215 hours on 17th June 2023 no aircraft is to fly below the base of controlled airspace within the area bounded by—

 - (v) 514312N 0004752E,

(5) Subject to paragraphs (11), (12) and (15), between 1140 hours and 1215 hours on 17th June 2023 no aircraft is to fly below 2,500 feet above mean sea level within the area bounded by—

- (a) a straight line between 512610N 0000747E and 512640N 0000811W,
- (b) the clockwise arc of a circle having a radius of 12 nautical miles centred at 512812N 0002713W between 512640N 0000811W and 512013N 0001255W,
- (c) straight lines joining successively the following points—
 - (i) 512013N 0001255W,
 - (ii) 512013N 0003800W, and
 - (iii) 512104N 0004242W,
- (d) the clockwise arc of a circle having a radius of 12 nautical miles centred at 512812N 0002713W between 512104N 0004242W and 513611N 0004133W,
- (e) a straight line between 513611N 0004133W and 513611N 0001253W,
- (f) the clockwise arc of a circle having a radius of 12 nautical miles centred at 512812N 0002713W between 513611N 0001253W and 513547N 0001221W,
- (g) a straight line between 513547N 0001221W and 513505N 0001022E,
- (h) the clockwise arc of a circle having a radius of 6.5 nautical miles centred at 513019N 0000319E between 513505N 0001022E and 513253N 0001253E,
- (i) a straight line between 513253N 0001253E and 513236N 0010256E, and
- (j) the clockwise arc of a circle having a radius of 5 nautical miles centred at 513019N 0000319E between 513236N 0010256E and 512610N 0000747E.

(6) Subject to paragraphs (14) and (15), between 1150 hours and 1230 hours on 17th June 2023 no aircraft is to fly below 2,500 feet above mean sea level within the area bounded by—

- (a) straight lines joining successively the following points-
 - (i) 512610N 0000747E,
 - (ii) 511618N 0000533E,
 - (iii) 511124N 0003003W,
 - (iv) 511107N 0003400W,
 - (v) 512033N 0003958W,
 - (vi) 512013N 0003800W, and
 - (vii) 512013N 0001255W,
- (b) the anti-clockwise arc of a circle having a radius of 12 nautical miles centred at 512812N 0002713W between 512013N 0001255W and 512640N 0000811W, and
- (c) a straight line between 512640N 0000811W and 512610N 0000747E.

(7) Subject to paragraphs (13), (14) and (15), between 1150 hours and 1230 hours on 17th June 2023 no aircraft is to fly below the base of controlled airspace within the area bounded by—

- (a) straight lines joining successively the following points-
 - (i) 513611N 0004133W,
 - (ii) 515245N 0013323W,

- (iii) 513943N 0012646W,
- (iv) 513911N 0012629W,
- (v) 513640N 0013011W,
- (vi) 513951N 0015702W,

(8) Subject to paragraphs (14) and (15), between 1150 hours and 1230 hours on 17th June 2023 no aircraft is to fly below Flight Level 105 within the area bounded by straight lines joining successively the following points—

- (c) 513640N 0013011W,
- (d) 513951N 0015702W,
- (e) 514830N 0020000W,
- (f) 515245N 0013323W, and
- (g) 513943N 0012646W.

(9) Subject to paragraphs (14) and (15), between 1150 hours and 1230 hours on 17th June 2023 no aircraft is to fly below Flight Level 105 within the area bounded by straight lines joining successively the following points—

- (a) 511030N 0013140W,
- (b) 511059N 0014641W,
- (c) 512915N 0015315W,
- (d) 512620N 0012925W,
- (e) 511835N 0012810W,
- (f) 511726N 0012843W, and
- (g) 511030N 0013140W.

(10) Paragraphs (1) to (4) do not apply to any aircraft—

- (a) flying in accordance with a permission issued by-
 - (i) 78 Squadron Royal Air Force Swanwick, or
 - (ii) the air traffic control unit at-
 - (aa) Royal Air Force Marham,
 - (bb) Wattisham Aerodrome, or
 - (cc) Southend Airport, or
- (b) making an approach to or departure from-
 - (i) Norwich Airport whilst under the direction of the air traffic control unit at that airport,

- (ii) Royal Air Force Lakenheath whilst under the direction of the air traffic control unit at that airfield, or
- (iii) Royal Air Force Mildenhall whilst under the direction of the air traffic control unit at that airfield.
- (11) Paragraph (5) does not apply to any aircraft—
 - (a) making an approach to or departing from-
 - (i) London Heathrow Airport whilst under the direction of either the London Terminal Control Centre at Swanwick or the air traffic control unit at London Heathrow Airport,
 - (ii) London City Airport whilst under the direction of either the London Terminal Control Centre at Swanwick or the air traffic control unit at London City Airport,
 - (iii) Royal Air Force Northolt whilst under the direction of either 78 Squadron Royal Air Force Swanwick or the air traffic control unit at Royal Air Force Northolt, or
 - (iv) the London Heliport Battersea whilst under the direction of the London Terminal Control Centre Swanwick or the air traffic control unit at London Heliport, or
 - (b) flying with a permission issued by 78 Squadron Royal Air Force Swanwick.

(12) Paragraph (5) does not apply insofar as flying is already prohibited by the Air Navigation (Restriction of Flying) (Isle of Dogs) Regulations 2004(**a**), the Air Navigation (Restriction of Flying) (City of London) Regulations 2004(**b**), the Air Navigation (Restriction of Flying) (Specified Area) Regulations 2005(**c**), the Air Navigation (Restriction of Flying) (Hyde Park) Regulations 2017(**d**), and the Air Navigation (Restriction of Flying) (Windsor Castle) Regulations 2021(**e**).

(13) Paragraphs (3) and (7) do not apply insofar as flying is already prohibited by the Air Navigation (Restriction of Flying) (Nuclear Installations) Regulations $2016(\mathbf{f})$.

(14) Paragraphs (6) to (9) do not apply to any aircraft flying in accordance with a permission issued by—

- (a) 78 Squadron Royal Air Force, Swanwick, or
- (b) the air traffic control unit at—
 - (i) Farnborough Airport,
 - (ii) Royal Air Force Odiham,
 - (iii) Royal Air Force Benson,
 - (iv) Royal Air Force Brize Norton, or
 - (v) Ministry of Defence Boscombe Down.
- (15) Paragraphs (1) to (9) do not apply to any aircraft—
 - (a) operated by or on behalf of the—
 - (i) Maritime and Coastguard Agency,
 - (ii) Helicopter Emergency Medical Service, or
 - (iii) National Police Air Service, or
 - (b) flying in accordance with the permission of the Royal Air Force King's Birthday Flypast Project Officer.

Revocation of Regulations

4. The Air Navigation (Restriction of Flying) (His Majesty the King's Birthday Flypast) Regulations 2023(**a**) are revoked.

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations impose restrictions on flying in the vicinity of the North Sea, Suffolk, Norfolk, Essex, Kent, Surrey, Berkshire, Buckinghamshire, Oxfordshire, Gloucestershire, Wiltshire and Central London for a large formation flypast of aircraft that is scheduled to take place there on 17th June 2023 to commemorate the birthday of His Majesty the King.

As timings for this event are critical and the formation may not be able to take effective avoiding action, the Civil Aviation Authority and the Department for Transport agree that it is in the public interest to restrict flying in the vicinity of the relevant areas to avoid the risk that transient aircraft may disrupt the formation.

These Regulations also revoke the Air Navigation (Restriction of Flying) (His Majesty the King's Birthday Flypast) (Regulations) 2023 (S.I. 2023/489) as these are no longer considered necessary.

These Regulations apply except insofar as flying is already prohibited by the Air Navigation (Restriction of Flying) (Isle of Dogs) Regulations 2004 (S.I. 2004/2091), the Air Navigation (Restriction of Flying) (City of London) Regulations 2004 (S.I. 2004/2092), the Air Navigation (Restriction of Flying) (Specified Area) Regulations 2005 (S.I. 2005/964), the Air Navigation (Restriction of Flying) (Nuclear Installations) Regulations 2016 (S.I. 2016/1003), the Air Navigation (Restriction of Flying) (Hyde Park) Regulations 2017 (S.I. 2017/1300), and the Air Navigation (Restriction of Flying) (Windsor Castle) Regulations 2021 (S.I. 2021/1137).

The times mentioned in regulation 3 are Co-ordinated Universal Time (UTC) which is one hour behind British Summer Time (BST).

In relation to the permission mentioned in regulation 3(15)(b), the Royal Air Force King's Birthday Flypast Project Officer may be contacted as notified.

Full details of this Statutory Instrument will be promulgated by a Briefing Sheet and Notice to Aviation (NOTAM).
