# The Air Navigation (Restriction of Flying) (Download Festival, Leicestershire) Regulations 2024

*Made - - - - 15th February 2024* 

Coming into force - - 13th June 2024

The Secretary of State has decided that it is necessary in the public interest to restrict the flying of unmanned aircraft in the area specified in regulation 3(1) by reason of the intending gathering there of a large number of persons at the 2024 Download Festival.

The Secretary of State makes the following Regulations in exercise of the powers conferred by article 239 of the Air Navigation Order 2016(a).

#### Citation and commencement

**1.** These Regulations may be cited as the Air Navigation (Restriction of Flying) (Download Festival, Leicestershire) Regulations 2024 and they come into force on 13th June 2024.

### Interpretation

**2.** In regulation 3(1) the times referred to are Co-ordinated Universal Time(**b**).

## Restricted airspace

- **3.**—(1) Subject to paragraph (2), between 1100 hours on 13th June 2024 and 1100 hours on 17th June 2024 no unmanned aircraft is to fly below 1,000 feet above mean sea level within the area bounded by a circle having a radius of 1 nautical mile centred at 524940N 0012235W.
- (2) Paragraph (1) does not apply to any unmanned aircraft flying in accordance with a permission issued by the Leicestershire Police.

#### **EXPLANATORY NOTE**

(This note is not part of the Regulations)

These Regulations impose restrictions on the flying of unmanned aircraft in the vicinity of Donington Park during the 2024 Download Festival that is due to take place there between 13th June 2024 and 17th June 2024 (inclusive).

At the request of the Leicestershire Police, the Civil Aviation Authority and the Department for Transport agree that the flying of unmanned aircraft should be restricted in the vicinity of the event location for reasons of public safety.

The times mentioned in regulation 3(1) are Co-ordinated Universal Time (UTC) which is one hour behind British Summer Time (BST).

In relation to the permission mentioned in regulation 3(2), Leicestershire Police may be contacted as notified.

Full details of this Statutory Instrument will be promulgated by Aeronautical Information Circular (AIC) and Notice to Aviation (NOTAM).
