# The Air Navigation (Restriction of Flying) (Cleethorpes) Regulations 2024

Made - - - - 12th April 2024

Coming into force - - 29th June 2024

The Secretary of State has decided that it is necessary in the public interest to restrict flying in the area specified in regulation 3(1) by reason of the intended holding there of flying displays.

The Secretary of State makes these Regulations in exercise of the powers conferred by article 239 of the Air Navigation Order 2016(a).

#### Citation and commencement

**1.** These Regulations may be cited as the Air Navigation (Restriction of Flying) (Cleethorpes) Regulations 2024 and they come into force on 29th June 2024.

## Interpretation

**2.** In regulation 3(2) the times referred to are Co-ordinated Universal Time(**b**).

## Restricted airspace

- **3.**—(1) Subject to paragraph (3), during the periods specified in paragraph (2) no aircraft is to fly below 3,000 feet above mean sea level within the area bounded by a circle having a radius of 2 nautical miles centred at 533332N 0000120W.
- (2) The periods referred to in paragraph (1) are between 1130 hours and 1630 hours on each of the two days beginning on 29th June 2024 and ending on 30th June 2024.
  - (3) Paragraph (1) does not apply to any aircraft—
    - (a) operated by or on behalf of the—
      - (i) National Police Air Service,
      - (ii) Helicopter Emergency Medical Services, or
      - (iii) Maritime and Coastguard Agency, or
    - (b) flying with the permission of the Cleethorpes Armed Forces Day Airshow flying display director.

#### EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations impose restrictions on flying in the vicinity of Cleethorpes, Lincolnshire during flying displays that are due to take place there on the 29th and 30th June 2024.

A large number of aircraft will be involved in high energy manoeuvres during the displays and therefore the Civil Aviation Authority and the Department for Transport agree that flying should be restricted in the vicinity of the event location for reasons of public safety.

The times mentioned in regulation 3(2) are Co-ordinated Universal Time (UTC) which is one hour behind British Summer Time (BST).

In relation to the permission mentioned in regulation 3(3)(b), the Cleethorpes Armed Forces Day Airshow flying display director may be contacted as notified.

Full details of this Statutory Instrument will be promulgated by Aeronautical Information Circular (AIC) and Notice to Aviation (NOTAM).
