The Air Navigation (Restriction of Flying) (His Majesty the King's Birthday Flypast) Regulations 2024

The Secretary of State has decided that it is necessary in the public interest to restrict flying in the areas specified in regulation 3 by reason of the holding there of a large formation flypast of aircraft to commemorate the birthday of His Majesty the King.

The Secretary of State makes the following Regulations in exercise of the powers conferred by article 239 of the Air Navigation Order $2016(\mathbf{a})$.

Citation and commencement

1. These Regulations may be cited as the Air Navigation (Restriction of Flying) (His Majesty the King's Birthday Flypast) Regulations 2024 and they come into force on 15th June 2024.

Interpretation

2. In regulation 3 the times referred to are Co-ordinated Universal Time(**b**).

Restricted airspace

3.—(1) Subject to paragraphs (6) and (13), between 1000 hours and 1300 hours on 15th June 2024 no aircraft is to fly below 10,000 feet above mean sea level within the area bounded by straight lines joining successively the following points—

- (a) 530000N 0023500E,
- (b) 530000N 0031300E,
- (c) 521300N 0023400E,
- (d) 520500N 0015000E,
- (e) 522200N 0012000E, and
- (f) 530000N 0023500E.

(2) Subject to paragraphs (6) and (13), between 1130 hours and 1225 hours on 15th June 2024 no aircraft is to fly below 5,000 feet above mean sea level within the area bounded by straight lines joining successively the following points—

(a) 521650N 0012910E,

- (f) 514628N 0003949E, and
- (g) 515039N 0003538E.

(5) Subject to paragraphs (6) and (13), between 1140 hours and 1225 hours on 15th June 2024 no aircraft is to fly below 2,500 feet above mean sea level within the area bounded by straight lines joining successively the following points—

- (a) 513433N 0000433W,
- (b) 515039N 0003538E,
- (c) 514628N 0003949E,
- (d) 513409N 0000826E, and
- (e) 513433N 0000433W.

(6) Paragraphs (1) to (5) do not apply—

- (a) insofar as flying is already prohibited by the Air Navigation (Restriction of Flying) (Nuclear Installations) Regulations 2016(a) and the Air Navigation (Restriction of Flying) (Prisons and Young Offender Institutions) (England and Wales) Regulations 2023(b),
- (b) to any aircraft flying in accordance with a permission issued by—
 - (i) 78 Squadron Royal Air Force, Swanwick,
 - (ii) the air traffic control unit at Wattisham Aerodrome, or
 - (iii) Southend Lower Airspace Radar Service, or
- (c) to any aircraft making an approach to or departure from Norwich Airport under the control of the air traffic control unit at that airport.

(7) Subject to paragraphs (8) and (13), between 1140 hours and 1225 hours on 15th June 2024 no aircraft is to fly below 2,500 feet above mean sea level within the area bounded by—

- (a) straight lines joining successively the following points—
 - (i) 513611N 0004133W,
 - (ii) 513611N 0001253W,
- (b) the clockwise arc of a circle having a radius of 12 nautical miles centred at 512812N 0002713W between 513611N 0001253W and 513445N 0001108W, and
- (c) straight lines joining successively the following points—
 - (i) 513445N 0001108W,
 - (ii) 513409N 0000826E,
 - (iii) 512700N 0000826E,
 - (iv) 512700N 0004133W, and
 - (v) 513611N 0004133W.

(8) Paragraph (7) does not apply—

- (a) insofar as flying is already prohibited by the Air Navigation (Restriction of Flying) (Prisons) Regulations 2001(a), the Air Navigation (Restriction of Flying) (City of London) Regulations 2004(b), the Air Navigation (Restriction of Flying) (Specified Area) Regulations 2005(c), the Air Navigation (Restriction of Flying) (Hyde Park) Regulations 2017(d), the Air Navigation (Restriction of Flying) (Windsor Castle) (Restricted Area EG R156) Regulations 2021(e), and the Air Navigation (Restriction of Flying) (Prisons and Young Offender Institutions) (England and Wales) Regulations 2023(f),
- (b) to any aircraft making an approach to or departure from-
 - (i) London Heathrow Airport whilst under the direction of either the London Terminal Control Centre at Swanwick or the air traffic control unit at London Heathrow Airport,
 - (ii) London City Airport whilst under the direction of either London Terminal Control Centre at Swanwick or the air traffic control unit at London City Airport,
 - (iii) Royal Air Force Northolt whilst under the direction of either 78 Squadron Royal Air Force, Swanwick or the air traffic control unit at Royal Air Force Northolt, or
 - (iv) the London Heliport, Battersea whilst under the direction of the London Terminal Control Centre, Swanwick or the air traffic control unit at London Heliport, or
- (c) to any aircraft flying in accordance with a permission issued by—
 - (i) 78 Squadron Royal Air Force, Swanwick, or
 - (ii) the London Terminal Control Centre, Swanwick.

(9) Subject to paragraphs (12) and (13), between 1200 hours and 1240 hours on 15th June 2024 no aircraft is to fly below 2,500 feet above mean sea level within the area bounded by straight lines joining successively the following points—

- (a) 515008N 0004230W,
- (b) 513611N 0002353W,
- (c) 513611N 0004133W,
- (d) 514458N 0004602W, and
- (e) 515008N 0004230W.

 - (i) 78 Squadron Royal Air Force, Swanwick,
 - (ii) Farnborough Lower Airspace Radar Service,

 - (iv) the air traffic control unit at-
 - (aa) Oxford Airport,
 - (bb) Royal Air Force Benson, or
 - (cc) Royal Air Force Brize Norton.
- (13) Paragraphs (1) to (5), (7) and (9) to (11) do not apply to any aircraft—
 - (a) operated by or on behalf of the—
 - (i) National Police Air Service,
 - (ii) Helicopter Emergency Medical Services, or
 - (iii) Maritime and Coastguard Agency, or
 - (b) operating with the permission of the Royal Air Force King's Birthday Flypast Project Officer.

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations impose restrictions on flying in the vicinity of East Anglia and the North Sea, Norfolk, Suffolk, Essex, London, and areas to the West and North of London over Berkshire, Buckinghamshire and Oxfordshire for the occasion of His Majesty the King's Birthday Flypast which is due to take place there on 15th June 2024.

As timings for this event are critical and the formation may not be able to take effective avoiding action, the Civil Aviation Authority and the Department for Transport agree that flying should be restricted in the vicinity of the relevant areas to avoid the risk that transient aircraft may disrupt the formation.

These Regulations apply except insofar as flying is already prohibited by the Air Navigation (Restriction of Flying) (Prisons) Regulations 2001 (S.I. 2001/1657, amended by S.I. 2007/2377), the Air Navigation (Restriction of Flying) (City of London) Regulations 2004 (S.I. 2004/2092), the Air Navigation (Restriction of Flying) (Specified Area) Regulations 2005 (S.I. 2005/964), the Air Navigation (Restriction of Flying) (Nuclear Installations) Regulations 2016 (S.I. 2016/1003), the Air Navigation (Restriction of Flying) (Hyde Park) Regulations 2017 (S.I. 2017/1300), the Air Navigation (Restriction of Flying) (Windsor Castle) (Restricted Area EG R156) Regulations 2021 (S.I. 2021/1137), and the Air Navigation (Restriction of Flying) (Prisons and Young Offender Institutions) (England and Wales) Regulations 2023 (S.I. 2023/1101).

The times mentioned in regulation 3 are Co-ordinated Universal Time (UTC) which is one hour before British Summer Time (GMT).
