CONVENTION BETWEEN THE UNITED KINGDOM

Signed at London, November 9, 1909.

HIS Majesty the King of the United Kingdom of Great Britain and Ireland and of the British Dominions beyond the Seas, Emperor of India, and His Majesty the King of Norway, signatories of the Convention for the pacific settlement of international disputes, concluded at The Hague on the 29th July, 1899;

Taking into consideration that by Article 19 of that Convention the High Contracting Parties have reserved to themselves the right of concluding Agreements, with a view to referring to arbitration all questions which they shall consider possible to submit to such treatment,

Have named as their Plenipotentiaries:—

His Majesty the King of the United Kingdom of Great Britain and Ireland and of the British Dominions beyond the Seas, Emperor of India, the Right Honourable Sir Edward Grey, a Baronet of the United Kingdom, a Member of Parliament, His Majesty's Principal Secretary of State for Foreign Affairs; and

HANS Majestæt Kongen av det forenede Kongerike Storbritannien og Irland og av de Britiske Besiddelser paa den anden side av havene, Keiser av Indien, og Hans Majestæt Kongen av Norge, som har undertegnet Overenskomsten om fredelig bilæggelse av internationale stridigheder, sluttet i Haag den 29de juli 1899;

Har, i betragtning av, at de höie kontraherende Parter ved artikel 19 i den nævnte overenskomst har forbeholdt sig at slutte avtaler om at henskyte til voldgivt alle de tilfælde, som de finder muligt at undergi saadan,

Opnævnt som sine Befuld-mægtigede:

Hans Majestæt Kongen av det forenede Kongerike Storbritannien og Irland og av de Britiske Besiddelser paa den anden side av havene, Keiser av Indien, the Right Honourable Sir Edward Grey, Baronet av det forenede Kongerike, Medlem av Parliamentet, Hans Majestæts förste Statssekretär for utenrikske anliggender; og

His Majesty the King of Norway, Monsieur Johannes Irgens, His Envoy Extraordinary and Minister Plenipotentiary at the Court of His Britannic Majesty;

Who, after having communicated to each other their respective full powers, found in good and due form, have agreed as follows:—

ARTICLE 1.

The High Contracting Parties hereby undertake to renew for a further period of 5 years, dating from the 9th instant, the Convention signed at London on the 11th August, 1904, for the settlement by arbitration of certain classes of questions which may arise between the two Governments, in so far as the provisions of the aforesaid Convention apply to the Kingdom of Norway.

Done in duplicate at London, the 9th day of November, 1909.

Hans Majestæt Kongen av Norge Herr Johannes Irgens, Hans Envoyé Extraordinaire og Ministre Plénipotentiaire hos Hans Britiske Majestæt;

Hvilke, efter at ha meddelt hinanden sine fuldmakter, fundet i god og behörig form, er kommet överens om fölgende:—

ARTIKEL 1.

De höie kontraherende Parter vedtar herved at fornye for et videre tidsrum av fem aar, at regne fra den 9de dennes, den i London under 11 august 1904 undertegnede överenskomst om avgjörelse ved voldgitt av visse slags spörsmaal som maatte komme til at opstaa mellem de to Regjeringer, forsaavidt som förnævnte överenskomsts bestemmelser angaar Kongeriket Norge.
