His Majesty's Ambassador at Copenhagen to the Danish Minister for Foreign Affairs

#### British Embassy,

M. le Ministre,

Copenhagen, 4th November, 1948.

In discussions now in progress between our two Governments with a view to renewal of the Agreement of 22nd April, 1947,(<sup>1</sup>) regarding the participation of a Danish military contingent in the occupation of the British Zone of Germany, it has, as your Excellency is aware, been found desirable that the time-limit for renewal of the Agreement, as laid down in Article 3 thereof, should be extended. His Majesty's Government in the United Kingdom accordingly propose the period within which an Agreement is to be concluded for this purpose, in accordance with Article 3, shall be prolonged by one month to end on 15th December, 1948.

If this proposal is acceptable to the Royal Danish Government, I have the honour, in the first instance, to propose this letter and your Excellency's reply thereto should constitute an Agreement between our two Governments to the above effect.
