#### EXCHANGE OF NOTES BETWEEN THE GOVERNMENT OF THE UNITED KINGDOM OF GREAT BRITAIN AND NORTHERN IRELAND AND THE GOVERNMENT OF GREECE FURTHER MODIFYING THE AGREEMENT OF 26TH NOVEMBER, 1945, REGARDING AIR SERVICES IN EUROPE

His Majesty's Ambassador at Athens to the Greek Minister for Foreign Affairs

Your Excellency,

British Embassy, Athens, 9th May, 1950.

I have the honour to refer to the Agreement signed at Athens on 26th November, 1945<sup>(1)</sup>, between the Government of the United Kingdom of Great Britain and Northern Ireland and the Royal Hellenic Government for Air Services in Europe as amended by Exchanges of Notes dated 21st February, 1947<sup>(1)</sup>, and 21st March, 1949<sup>(2)</sup>, and to inform you that the Government of the United Kingdom proposes that the Agreement as amended should be further modified as follows:—

(a) The following route should be added to Schedule I:

Nicosia-Rhodes or Crete-Athens.

(b) The following routes should be added to Schedule II:

- 1. Athens-Rhodes or Crete-Nicosia.
- 2. One of the following routes:

Athens-Rhodes or Crete-Nicosia-Lydda; or Athens-Rhodes or Crete-Nicosia-Beirut.

NOTE.—The Royal Hellenic Government shall notify the Government of the United Kingdom as soon as the designated airline of Greece begins to operate on one of these routes. Within one year of such notification the Royal Hellenic Government shall notify the Government of the United Kingdom which of the above routes it has chosen. The right to operate the other route shall then lapse.

- (c) In references in the Agreement to rights in the United Kingdom and to traffic to and from the United Kingdom, the expression "United Kingdom" should be deemed to include all points in United Kingdom territory specified in the Schedules to the Agreement.
- (d) Nothing in the Agreement as amended or in this Note shall be deemed to confer on the airlines of one contracting party the privilege of taking up in the territory of the other contracting party passengers, cargo or mail carried for remuneration or hire and destined for another point in the territory of that other contracting party.
- (e) A designated airline of either contracting party may on any or all flights omit calling at any of the points specified in the Schedules to the Agreement on the routes operated by it provided that the air services on these routes begin at a point in the territory of the contracting party which has designated the airline.

2. If the Royal Hellenic Government agree to the above proposals, I have the honour to suggest that this Note and your Excellency's reply shall be regarded as constituting an agreement between our two Governments which shall come into force as from to-day.
