His Majesty's Ambassador at Rio de Janeiro to the Brazilian Minister of State for Foreign Affairs (ad interim)

British Embassy, Rio de Janeiro, 2nd April, 1951. Your Excellency,

I have the honour to refer to consultations between officials of the Brazilian Government and of this Embassy regarding the continuance in force of Part II of the Trade and Payments Agreement between the Governments of the United Kingdom of Great Britain and Northern Ireland and the United States of Brazil of 21st May, 1948(1), and to propose that Articles 15, 16, 17, 19 (a) to (d) and 20 of the above-mentioned Agreement shall continue in force for another period of one year.

2. If the Government of Brazil agrees, I have the honour to propose that this Note and your Excellency's reply be regarded as constituting an Agreement on the above terms, between our two Governments, which shall be deemed to have come into force on 1st April, 1951.
