EXCHANGE OF NOTES BETWEEN THE GOVERNMENT OF THE UNITED KINGDOM OF GREAT BRITAIN AND NORTHERN IRELAND AND THE BELGIAN GOVERNMENT TERMINATING THE AGREEMENT OF 6th OCTOBER, 1944, CONCERNING PROPERTY IN THE UNITED KINGDOM BELONGING TO PERSONS RESIDENT IN BELGIUM

The Secretary of State for Foreign Affairs to the Belgian Ambassador at London

Your Excellency,

Foreign Office, 1st May, 1952.

I have the honour to refer to the Agreement between the Government of the United Kingdom of Great Britain and Northern Ireland and the Belgian Government relating to Property in the United Kingdom belonging to Persons resident in Belgium, signed in London on 6th October, 1944(1).

I have the honour to propose that, since the purposes for which this Agreement was made have been so satisfactorily concluded, and the orderly return to its proper owners of property in the United Kingdom belonging to persons in Belgium has been almost completed, this Agreement should hereby be terminated.

Her Majesty's Government propose, on the termination of this Agreement, to issue an Enemy Territory Cessation Order for Belgium removing the operation of Regulation 6 of the Defence (Trading with the Enemy) Regulations whereby Belgium at present continues to be enemy territory for certain purposes of the Trading with the Enemy Act. All Belgian persons will then be free to deal with their property in the United Kingdom without further Trading with the Enemy restrictions and the Custodian of Enemy Property will release on application any money paid to him, or property held by him for the account of Belgian persons, except such property or money as came under Trading with the Enemy control for reasons other than the occupation of Belgium by the enemy, as for example ownership by belligerent enemy nationals.

If the arrangements proposed herein meet with the approval of the Belgian Government, I have the honour to propose that the present Note, together with your Excellency's reply in that sense, should constitute an Agreement between our two Governments formally terminating with effect from to-day's date the above-mentioned Agreement of 6th October, 1944.
