British Embassy.

M. le Délégué,

Berne, June 24, 1953. I have the honour, upon instructions from Her Majesty's Prime Minister, to refer to the Exchange of Notes dated the 29th of December,  $1952,(^{1})$ extending the Monetary Agreement between the Governments of the United Kingdom of Great Britain and Northern Ireland and the Swiss Government of the 12th of March, 1946,  $(^2)$  for a further period of six months from the 31st of December, 1952, and to propose that that Agreement, which has from time to time been extended and modified by Exchanges of Letters and Notes between the two Governments,(3) shall be further extended from the 1st of July, 1953, and shall remain in force so long as bilateral balances between the United Kingdom and Switzerland are settled through the European Payments Union, provided that either Government may terminate the Agreement constituted by this Exchange of Notes at any earlier date on giving to the other three months' notice of its intention to do so.

If the Swiss Government agree to this proposal, I have the honour to suggest that the present Note and your reply in that sense shall be regarded as constituting an Agreement between the two Governments.
