Rome, July 1, 1953. I have the honour to invite reference to the Convention regarding the promotion of cultural relations between the United Kingdom and Italy which was signed in Rome on the 28th of November, 1951,(1) and to inform your Excellency that Her Majesty's Government propose, in accordance with the provisions of Article XVII thereof, to appoint the British Council as their principal agent for the execution of the measures falling within the scope of the Convention.

If the Italian Government agree with the foregoing proposal, I have the honour to suggest that the present Note and your Excellency's reply to that effect should be considered as placing formally on record the agreement of the two Governments in this matter.

Rome, July 1, 1953. I have the honour to invite reference to the Note addressed to your Excellency to-day regarding the Anglo-Italian Cultural Convention signed in Rome on the 28th of November, 1951, and to inform your Excellency that Her Majesty's Government, in addition to appointing the British Council as their principal agent for the execution of the provisions of the Convention, propose, in accordance with Article XVII of the Convention, to appoint as another agent the British Institute, Florence. The British Institute at Florence is an independent foundation of long standing engaged in pursuing the same objects as the British Council and working in conjunction with the latter.

In addition I have the honour hereby to notify your Excellency, in accordance with paragraph 3 of Article II, of the desire of Her Majesty's Government that the British School at Rome should be added to the Institutes mentioned in paragraph 2 of Article II and to state that Her Majesty's Government propose, in accordance with Article XVII, to appoint the said School as another agent for the execution of the provisions of the Convention. The British School at Rome is a separate organisation from that of the British Council and provides a residential centre in Rome and scholarships for the study of the history, art, archæology and architecture of Rome and Italy by British scholars and students.

If the foregoing notification and proposals are acceptable to the Italian Government, I have the honour to suggest that the present Note and your Excellency's reply to that effect should be considered as placing formally on record the agreement of the two Governments in this matter.
