British Embassy,

Your Excellency, Rome, September 19, 1953.

I have the honour to refer to the Sterling Payments Agreement between the Government of the United Kingdom of Great Britain and Northern Ireland and the Italian Government, which was signed at Rome on the 21st of December, 1950(1), and to the Notes exchanged between your Excellency and myself on the 23rd of January, 1953(2), relating to Article 11 of the Agreement.

I have the honour to propose, on instructions from Her Majesty's Acting Secretary of State for Foreign Affairs, that the agreement set out in the Notes of the 23rd of January, 1953, shall be terminated and that the second sentence of Article 11 of the Agreement of the 21st of December, 1950, shall be regarded

as deleted and the following new article added:-

"ARTICLE 12

The present Agreement shall continue in force for so long as bilateral balances between Italy and the United Kingdom are settled through the European Payments Union, provided that either Contracting Government may terminate the Agreement at any earlier date on giving to the other three months' notice of its intention."

If this proposal is acceptable to the Italian Government, I have the honour to suggest that this Note and your Excellency's reply in that sense should be regarded as constituting an agreement between our two Governments, which shall take effect immediately.

"Ho l'onore di riferirmi all'Accordo di pagamenti in sterline tra il Governo del Regno Unito di Gran Bretagna e dell'Irlanda del Nord e il Governo italiano, firmato a Roma il 21 dicembre 1950, e allo scambio di note intervenuto tra Vostra Eccellenza e me il 23 gennaio 1953, relativamente all'Art. 11 dell'Accordo.

Ho l'onore di proporre, dietro istruzioni ricevute dal Vice Segretario di Stato agli Affari Esteri, che l'Accordo concluso con lo scambio di note del 23 gennaio 1953 abbia termine e che il secondo paragrafo dell'Art. 11 dell'Accordo del 21 dicembre 1950 venga considerato annullato e vi sia aggiunto il seguente nuovo articolo:-

'ART. 12:

il presente Accordo resterà in vigore per tutto il tempo in cui i saldi bilaterali tra l'Italia e il Regno Unito saranno regolati attraverso l'Unione Europea dei pagamenti, nell'intesa che ciascuno dei Governi contraenti potrà porre termine all'Accordo in qualsiasi momento anteriore, dando communicazione all'altra Parte della propria intenzione con un preavviso di tre mesi.'

Qualora il Governo italiano accetti tale proposta, ho l'onore di suggerire che questa Nota e la risposta di Vostra Eccellenza vengano considerate come costituenti un accordo intervenuto tra i nostri Governi, avente effetto immediato".

In relazione a quanto precede, ho l'onore d'informare Vostra Eccellenza che il Governo italiano accetta la proposta, nonchè il suggerimento di considerare il presente scambio di note come constituente un accordo fra i due Governi.
