Brussels, October 20, 1954.

I have the honour to refer to the Agreement constituted by the Notes exchanged at Brussels on the 29th of April, 1938,(1) between the Government of Belgium and Her Majesty's Government in the United Kingdom of Great Britain and Northern Ireland, regarding the acceptance of licences or certificates of competency of the operating personnel of aircraft employed on regular airlines in lieu of national passports.

In the view of Her Majesty's Government the arrangements set out in the above-mentioned Agreement have been superseded by paragraph 3 (10) of the first edition of Annex 9 to the Convention on International Civil Aviation (paragraph 3 (9) in the current second edition).(2) The first edition of Annex 9 came into force on the 1st of March, 1950. If this view is also shared by the Government of Belgium, I have the honour to propose that the said Agreement should be formally terminated in respect of Her Majesty's Government as aforesaid and the Government of Belgium.

If this proposal is acceptable to the Government of Belgium, I suggest that the present Note and your Excellency's reply in that sense should be regarded as constituting an agreement between the Government of Belgium and Her Majesty's Government terminating, after a lapse of six months from to-day's date, the arrangements set out in the Exchange of Notes of the 29th of April, 1938.
