Her Majesty's Ambassador at Rio de Janeiro to the Brazilian Minister for Foreign Affairs

No. 66. Your Excellency, British Embassy, Rio de Janeiro, March 31, 1954.

I have the honour to refer to the Notes exchanged between the Ministry for Foreign Affairs and Her Britannic Majesty's Embassy on the 31st of March, 1953,(1) regarding the continuance in force of certain Articles of the Trade and Payments Agreement between the Governments of the United Kingdom of Great Britain and Northern Ireland and the United States of Brazil, of the 21st of May, 1948,(2) and to propose that Articles 15, 19 (a) to (d) and 20 of the above-mentioned Agreement shall continue in force for a further period of one year from the 1st of April, 1954, to the 31st of March, 1955, both dates inclusive.

2. If the Government of Brazil agrees, I have the honour to propose that your reply in that sense and this Note be regarded as constituting an Agreement between our two Governments in the matter.
