Sir Winston Churchill to the Greek Ambassador at London

Foreign Office, S.W. 1. August 13, 1954.

Your Excellency, I have the honour to refer to the Agreement between the Government of the United Kingdom of Great Britain and Northern Ireland and the Royal Hellenic Government, relating to Money and Property situated in Greece and the United Kingdom and subject to special measures in consequence of the enemy occupation of Greece, which was signed at London on the 21st of March, 1946,(1) and to inform your Excellency that the Government of the United Kingdom consider that the purposes for which this Agreement was concluded have been achieved and that it may now be terminated.

If this view is shared by the Royal Hellenic Government, I have to suggest that the present Note and your Excellency's reply to that effect should be regarded as constituting an Agreement between the two Governments, formally terminating with effect from to-day's date, the above-mentioned Agreement of

the 21st of March, 1946.
