The Head of the Swedish Delegation to the Organisation for European Economic Co-operation to the Head of the United Kingdom Delegation to that Organisation

Swedish Delegation,

Your Excellency. Paris, December 22, 1955.

I have the honour to refer to the conversations which have recently taken place between representatives of our two Delegations about the repayment of part of the United Kingdom's outstanding "existing resources" debt to Sweden as at the 30th June. 1950, and to make the following proposal:—

- I. An amount of £8,400,000 shall be repaid by the United Kingdom in four equal monthly instalments to be included in the calculation of the bilateral surpluses or deficits in the European Payments Union of the United Kingdom and Sweden in respect of the months of December 1955 and of January, February and March 1956.
- 2. The remainder, £8,438,214 5s. 9d. of the balance now outstanding shall, as hitherto, be available for use by Sweden in accordance with Article 9 (a) of the Agreement for the Establishment of a European Payments Union.(1)

If you agree with this proposal. I have the honour to suggest that this letter, together with your reply to that effect, shall be regarded as constituting an agreement between the two Governments.
