# EXCHANGE OF NOTES BETWEEN THE GOVERNMENT OF THE UNITED KINGDOM OF GREAT BRITAIN AND NORTHERN IRELAND AND THE GOVERNMENT OF BRAZIL PROLONGING CERTAIN ARTICLES OF THE TRADE AND PAYMENTS AGREEMENT OF THE 21st OF MAY, 1948

Rio de Janeiro, March 31, 1955.
Your Excellency,
I have the honour to refer to the Notes exchanged between the Ministry for Foreign Affairs and Her Britannic Majesty's Embassy on the 31st of March, 1954, $\left(^{( }\right)$regarding the continuance in force of certain Articles of the Trade and Payments Agreement between the Governments of the United Kingdom of Great Britain and Northern Ireland and the United States of Brazil, of the 21st of May, 1948, $\left({ }^{2}\right)$ and to propose that Articles 15, 19 (a) to (d) and 20 of the above-mentioned Agreement shall continue in force for a further period of three months from the 1st of April, 1955, to the 30 th of June, 1955, both dates inclusive.
2. If the Government of Brazil agrees, the present Note and your Excellency's Note of the same tenor, of this date, shall constitute an agreement between our two Governments on this matter. I avail, \&c.

Senhor Embaixador,
Com referếncia às notas trocadas entre o Ministério das Relações Exteriores e a Embaixada de Sua Majestade Britânica, em 3I de março de 1954, relativas à prorrogação da vigência de certos artigos do Acôrdo de Comércio e Pagamentos entre os Governos do Brasil e do Reino Unido da Grã-Bretanha e Irlanda do Norte, de 21 de maio de 1948, tenho a honra de propor que os artigos 15,19 (a) até (d) e 20 do mencionado Acôrdo continuem em vigor por um período adicional de três meses, a partir de $1^{\circ}$ de abril de 1955 até 30 de junho de 1955, inclusive.
2. A presente nota e a do mesmo teor de vossa Excelência, ambas da mesma data, constituem Acôrdo formal entre os dois Governos sôbre o assunto.
