EXCHANGE OF NOTES BETWEEN THE GOVERNMENT OF THE UNITED KINGDOM OF GREAT BRITAIN AND NORTHERN IRELAND AND THE GOVERNMENT OF ETHIOPIA PROVIDING FOR THE TERMINATION OF THE LEASE OF THE GAMBEILA ENCLAVE

Your Excellency,

Addis Ababa, July 5, 1955.

I have the honour to refer to Article IV of the Treaty concluded between our two Governments and signed at Addis Ababa on May 15, 1902.(1) As your Excellency is aware, it is the view of Her Majesty's Government in the United Kingdom that the period of lease of the Gambeila enclave under the term of that Article runs until the termination of the condominium in the Sudan, which will represent the termination of Anglo-Egyptian government there. The legal termination of the condominium will in their view actually take effect at the moment when the Governor-General of the Sudan hands over his powers to a new Government of the Sudan and leaves the country. This transfer of power may be expected to take place during the first quarter of 1957.

- 2. Her Majesty's Government in the United Kingdom are nevertheless aware of the desire of the Imperial Ethiopian Government to secure an early termination of the lease of the Gambeila enclave. Accordingly I have the honour to inform your Excellency that Her Majesty's Government in the United Kingdom are prepared, without prejudice to the legal interpretation of Article IV of the aforesaid Treaty and in the interests of meeting the expressed desire of the Imperial Ethiopian Government, to agree that the actual return of the Gambeila enclave in full sovereignty to the Imperial Ethiopian Government shall take place during the flood season of 1956; that is to say, during the period mid-July to mid-October; and shall be finally completed by mid-October 1956. I am also to propose that in July 1956 negotiations should begin in Gambeila between representatives of your Government and of the Government of the Sudan regarding details of the hand-over, including inter alia such matters as the disposal of physical assets and the transfer of administration.
- 3. If the foregoing proposals are acceptable to the Imperial Ethiopian Government I have the honour to suggest that the present Note and your Excellency's reply to that effect should be regarded as constituting an agreement between our two Governments in this matter.
