Paris, December 8, 1956.

I have the honour to refer to the conversations which have recently taken place between representatives of our two Delegations about the repayment of the balance now remaining of the United Kingdom's "existing resources" debt to Sweden established at the 30th June, 1950, and to make the following proposal:—

The outstanding balance of £8,438,214 5s. 9d. shall be repaid by the United Kingdom in five equal monthly instalments each of £1,400,000 to be included in the calculation of the bilateral surpluses or deficits in the European Payments Union of the United Kingdom and Sweden in respect of the months of January to May, 1957, inclusive, and a final instalment of £1,438,214 5s. 9d. to be included in the calculation in respect of June 1957.

If you agree with this proposal I have the honour to suggest that this letter, together with your reply to that effect, shall be regarded as constituting an agreement between the two Governments.
