EXCHANGE OF NOTES BETWEEN THE GOVERNMENT OF THE UNITED KINGDOM OF GREAT BRITAIN AND NORTHERN IRELAND AND THE GOVERNMENT OF THE KINGDOM OF BELGIUM AMENDING PARAGRAPH 4 (c) OF ARTICLE VII OF THE AGREEMENT OF NOVEMBER 18, 1955 FOR CO-OPERATION IN THE PEACEFUL USES OF ATOMIC ENERGY

Your Excellency,

I have the honour to refer to the Agreement for Co-operation in the peaceful uses of Atomic Energy, signed at London on the 18th of November, 1955 between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of the Kingdom of Belgium. (1) Article VII, paragraph 4 (c) of the Agreement, provides that the Combined Development Agency shall "be entitled to purchase such additional quantities of uranium ores and concentrates as may be required for the production of the materials sold to Belgium by the Authority in accordance with subparagraphs (b) (i) and (ii) of this paragraph during any one year." Since this clause was intended to provide for an option on the part of the Combined Development Agency for the purchase of the ores and concentrates required for the production of the materials referred to in paragraphs 1 and 2 of Article VII, paragraph 4 (c) of that Article as at present drafted is misleading.

If this is also the understanding of the Belgian Government I have to propose that paragraph 4 (c) of Article VII of the Agreement should be amended by correcting the first sentence to read as follows:—

"In addition to those percentages which the Combined Development Agency shall have first option to purchase with respect to any calendar year, the Combined Development Agency shall also be entitled to purchase such additional quantities of uranium ores and concentrates as may be required for the production of the materials sold to Belgium by the Authority in accordance with paragraphs 1 and 2 of this Article during any one year."

If the above mentioned proposal is acceptable to the Belgian Government, I have to suggest that this Note, together with your Excellency's reply to that effect, should be regarded as constituting an agreement between the two Governments, amending the Agreement of the 18th of November, 1955 accordingly.

J'ai l'honneur d'accuser la réception de la Note de votre Excellence de ce jour proposant que la première phrase du paragraphe 4 (c) de l'article VII de l'Accord du 18 novembre 1955 entre le Gouvernement du Royaume-Uni et le Gouvernement belge en matière de coopération pour les utilisations pacifiques de l'énergie atomique, soit amendée comme suit:—
