The Czechoslovak Ambassador in London to the Secretary of State for Foreign Affairs

Embassy of the Czechoslovak Republic, London, 18th May, 1956.

Sir,

The Sterling Payments Agreement between the Government of the Czechoslovak Republic and the Government of the United Kingdom of Great Britain and Northern Ireland, signed in London on the 18th August, 1949,(1) amended by an Exchange of Notes on the 28th December, 1950,(2) extended by an Exchange of Notes on the 18th of August and the 1st of September, 1955,(3) and further extended by an Exchange of Notes on the 17th and 29th of November, 1955,(4) is due to expire on the 19th May, 1956. I have the honour to propose that this Agreement shall continue in force for a period of three months after the 19th May, 1956.

If the Government of the United Kingdom agree to this proposal, I have the honour to suggest that the present Note and your reply to that effect shall be regarded as constituting an Agreement between the two Governments.

I have the honour to acknowledge receipt of your Excellency's Note of the 18th of May, 1956, proposing that the Sterling Payments Agreement between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of the Czechoslovak Republic, signed
