RESOLUTION OF THE INTERNATIONAL TIN COUNCIL REGARDING THE AMENDMENT OF THE INTERNATIONAL TIN AGREEMENT

The International Tin Council,

Desiring to make an amendment to the International Tin Agreement, opened for signature at London on the 1st March, 1954,(1) recommend, pursuant to paragraph 1 of Article XVIII of the Agreement,

(a) the following amendment to the Contracting Governments for their ratification or acceptance: --

Paragraph 22 of Article IV shall be deleted and the following paragraphs shall be inserted in place thereof: --

- The Council shall have in each participating country, to the extent consistent with its law, such exemption from taxation on the assets, income and other property of the Council as may be necessary for the discharge of its functions under this Agreement.
- The Government of the country in which the seat of the Council is situated shall grant exemption from taxation on remuneration paid by the Council to its employees other than those employees who are nationals of the country in which the seat of the Council is.'

and

(b) that twenty months from the date of this Resolution be fixed as the time within which Contracting Governments shall notify the Government of the United Kingdom of Great Britain and Northern Ireland of their ratification or acceptance in accordance with Article XVIII of the International Tin Agreement.(2)
