The Head of the Austrian Delegation to the Organisation for European Economic Co-operation to the Head of the United Kingdom Delegation to that Organisation

Your Excellency,

Paris, August 9, 1956

1. I have the honour to refer to the Notes exchanged on the 19th March, 1956, (1) between the Heads of the United Kingdom and Austrian Delegations to the Organisation for European Economic Co-operation providing, in the event of Austria ceasing to be a creditor of the Union, for the suspension of payments under the Agreement of 9th July, 1954, (2) between the Government of the United Kingdom of Great Britain and Northern Ireland and the Austrian Federal Government for the repayment of credit granted by the European Payments Union to the United Kingdom and by Austria to the Union.

II. Now that Austria is no longer a creditor in the European Payments Union the suspension of payments provided for in sub-paragraph 3 (a) of the Exchange of Notes on 19th March, 1956, referred to above is effective.

III. The Austrian Federal Government wish to avoid the inconvenience which might arise from a resumption of payments in the event of minor fluctuations in Austria's position in the European Payments Union and therefore propose that—

(a) the arrangements provided for in sub-paragraph 3 (b) of the Notes exchanged on 19th March. 1956 shall become operative only if, on the value date of the Union upon which payment would otherwise have been resumed, and on each of the two immediately preceding value dates of the Union, the cumulative accounting position of Austria as a creditor of the Union has amounted to at least 10 per cent. of the Austrian quota in the Union;

(b) if payments under the Agreement are resumed in accordance with the provisions of sub-paragraph (a) above, they shall continue to be made in accordance with the Agreement for as long as Austria remains a creditor of the Union; should Austria subsequently again become a debtor, the provisions of Article IV of the Agreement would then apply.
