The Burmese Ambassador in London to the Secretary of State for Foreign Affairs

Your Excellency,

London, January 9, 1957

I have the honour to refer to the Air Transport Agreement between the Government of the Union of Burma and the Government of the United Kingdom of Great Britain and Northern Ireland, signed at Rangoon on the 25th of October, 1952,⁽¹⁾ and to inform you that the Government of the Union of Burma propose that in Route 3 of the Burmese Schedule of Routes annexed to that Agreement the words "Bangkok and/or Penang" should be substituted for the words "Penang or Bangkok."

2. If this proposal is acceptable to the Government of the United Kingdom, I have the honour to suggest that this Note and your Excellency's, reply in that sense should be regarded as constituting an Agreement between our two Governments, which shall enter into force immediately.
