The United States Secretary of State to Her Majesty's Ambassador at Washington

Department of State,

Excellency,

Washington, April 24, 1957.

I have the honor to refer to conversations which have been conducted between representatives of our two Governments regarding a further extension of the arrangement set forth in paragraph 6 of the Joint Statement by the United States and the United Kingdom regarding Settlement for Lend-Lease, Reciprocal Aid, Surplus War Property and Claims dated December 6, 1945.(1) It will be recalled that by an Exchange of Notes dated April 28 and April 30, 1952.(2) this arrangement was extended from December 31, 1951 to December 31, 1958. It has been agreed in these conversations that this arrangement as modified by the Notes of April 28 and April 30, 1952 will continue in effect until the amount specified in paragraph 6 is entirely utilized by the Government of the United States.

If the foregoing is acceptable to the Government of the United Kingdom of Great Britain and Northern Ireland, I have the honor to suggest that this Note and your Excellency's reply to that effect shall be regarded as constituting

an agreement between our two Governments.
