I have the honour to refer to the Agreement constituted by the Exchange of Notes of 31st December, 1953.⁽¹⁾ as amended by the further Notes exchanged on 31st December, 1954.⁽²⁾ and 31st December, 1955.⁽³⁾ between the Government of the Federal People's Republic of Yugoslavia and the Government of the United Kingdom of Great Britain and Northern Ireland concerning the import of British books into Yugoslavia.
