## [Translation of No. 1]

My dear Sir Charles,

I have the honour to refer to the discussions which recently took place between His Excellency Sayid Hazza' al Majali and Mr. R. H. Mason about Jordan's present financial situation, and to propose that the arrangements agreed upon in paragraph 1 (b) of the Annex to the Agreement constituted by the Exchange of Notes, dated the 13th of March, 1957(1), terminating the Treaty of Alliance of the 15th of March, 1948(2), between the Government of the United Kingdom and the Government of the Hashemite Kingdom of Jordan, should be modified in such a way that payment of the second instalment of £500,000 sterling, which was due on the 1st of May, 1959, should be deferred until the 1st of May, 1965.

If the foregoing proposal is acceptable to the Government of the United Kingdom, I have the honour to suggest that the present Note and Your Excellency's reply thereto should be regarded as constituting an agreement between the two Governments in this matter.
