EXCHANGE OF NOTES BETWEEN THE GOVERNMENT OF THE UNITED KINGDOM OF GREAT BRITAIN AND NORTHERN IRELAND AND THE GOVERNMENT OF THAILAND AMENDING SECTION I OF THE SCHEDULE OF ROUTES ANNEXED TO THE AIR SERVICES **AGREEMENT NOVEMBER 10, 1950**

Her Majesty's Ambassador at Bangkok to the Thai Minister for Foreign Affairs

British Embassy,

Monsieur le Ministre,

Bangkok, October 26, 1959.

I have the honour to refer to the Agreement between the Royal Thai Government and the Government of the United Kingdom of Great Britain and Northern Ireland for air services between and beyond their respective territories, signed at Bangkok on the 10th of November, 1950,(1) and also to the following Notes from the Royal Thai Ministry of Foreign Affairs to this Embassy:

No. 21405/2499 of the 14th of July, 1956,

No. 40123/2499 of the 29th of December, 1956.

No. 3022/2501 of the 4th of February, 1958,

No. 10991/2501 of the 25th of April, 1958.

These Notes communicated the agreement of the Thai authorities to the exercise by the British Overseas Airways Corporation of traffic rights at Milan, Istanbul, Beirut and Damascus, and Teheran respectively.

As a result of these changes already agreed, the Government of the United Kingdom propose that Route I of Section I of the Schedule of Routes annexed to the Agreement should be amended to read as follows:

(1) (3)Points beyond (any one Destination or more of the following if desired) Point of Intermediate Points (any one or in Thai Departure more of the following) Territory London Frankfurt or Dusseldorf or Zurich Bangkok Hong Kong; points in the Philippines; or Geneva; Milan or Rome or Malta or Tripoli; Istanbul or Cyprus; Cairo or Lydda; Damascus; Beirut; Baghdad or points in China; points in Japan Basra or Bahrain or Dhahran; Teheran; Karachi; Bombay or Line to the territorial New Delhi; Calcutta; Dacca;

If this proposal is acceptable to the Royal Thai Government I have the honour to suggest that this Note and Your Excellency's reply in that sense should be regarded as constituting an Agreement between the two Governments in this matter which should enter into force immediately.
