AGREED MINUTE RELATING TO THE EXCHANGE OF NOTES BETWEEN THE GOVERNMENT OF GREAT BRITAIN AND NORTHERN IRELAND AND THE GOVERNMENT OF THE REPUBLIC OF TURKEY OF DECEMBER 9, 1960

The Government of Great Britain and Northern Ireland and the Government of the Republic of Turkey agree that the Agreement dated December 9, 1960(1) constituted by an Exchange of Notes between Her Majesty's Government and the Turkish Government which ended on June 1, 1961 and was extended to December 1, 1961(2) shall be extended for a further period of six months, ending on June 1, 1962, that for this purpose the date "the 1st of June 1961" in paragraphs (a), (b), (c) and (d) of the Agreement should be amended to read "the 1st of June 1962" and that further discussions on the matters mentioned in paragraphs (c) and (d) shall take place before June 1, 1962.

BÜYÜK BRITANYA VE ŞIMALÎ İRLANDA HÜKÛMETI ILE TÜRKIYE CUMHURIYETI HÜKÛMETI ARASINDA 9 ARALIK 1960 TARIHINDE NOTA TEATISI SURETILE AKDEDILEN ANLAŞMA ILE ILGILI OLARAK MUTABIK KALINAN HUSUSLARA DAIR TUTANAK

Büyük Britanya ve Şimalî İrlanda Hükûmeti ile Türkiye Cumhuriyeti Hükûmeti arasında mektup teatisi suretile akdedilmiş olan 9 Aralık 1960 tarihli Anlaşmanın 1 Haziran 1961 tarihinde nihayete ermiş olup 1 Aralık 1961 tarihine kadar uzatılmış bulunan süresinin, 1 Haziran 1962 tarihinde nihayete ermek üzere yeniden altı aylık bir devre için temdidi ve bu maksatla Anlaşmanın (a), (b), (c) ve (d) fıkralarındaki 1 Haziran 1961 tarihinin 1 Haziran 1962 olarak değiştirilmesi ve (c) ve (d) fıkralarında zikredilen mevzuların 1 Haziran 1962 tarihinden önce yeniden müzakere edilmesi hususlarında Majestelerinin Hükûmeti ile Türk Hükûmeti mutabıktırlar.
