Your Excellency.

Prime Minister's Office, Amman, June 8, 1961.

I have the honour to refer to our recent discussion about Jordan's present financial situation and to propose that the arrangements agreed upon in paragraph 1 (b) of the Annex to the Agreement constituted by the Exchange of Notes of March 13th, 1957(1), terminating the Treaty of Alliance of March 15th, 1948(2), between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of the Hashemite Kingdom of Jordan, should be modified in such a way that payment of the instalment of £500,000 sterling, which was due on May 1st, 1961, should be deferred until May 1st, 1967.

If the foregoing proposal is acceptable to the Government of the United Kingdom of Great Britain and Northern Ireland, I have the honour to suggest that the present Note and Your Excellency's reply in that sense should be regarded as constituting a legal agreement between the two Governments in this matter.
