EXCHANGE OF NOTES BETWEEN THE GOVERNMENT OF THE UNITED KINGDOM OF GREAT BRITAIN AND NORTHERN IRELAND AND THE GOVERNMENT OF THE REPUBLIC OF TURKEY **AMENDING** THE AGREEMENT CONCERNING **ARRANGEMENTS** CONSTITUTED BY FINANCIAL **EXCHANGE OF NOTES OF DECEMBER 9, 1960**

Her Majesty's Ambassador at Ankara to the Turkish Minister of Finance

British Embassy,

Monsieur le Ministre.

Ankara, June 23, 1962.

I have the honour to refer to the Agreement between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of the Republic of Turkey concerning Financial Arrangements for the period ending the 1st of June, 1961, relating to the Agreement of the 11th of February, 1954,(1) which was constituted by Notes exchanged at Ankara on the 9th of December, 1960,(2) and to the Agreed Minutes of the 31st of May,(3) and the 30th of November, 1961,(4) which extended the said Agreement to the 1st of December, 1961, and the 1st of June, 1962, respectively.

- Acting upon instructions from Her Majesty's Principal Secretary of State for Foreign Affairs, I now have the honour to propose that the said Agreement should be further extended from the 1st of June, 1962, until the 1st of December, 1962, and that for this purpose the date "the 1st of June, 1962", in paragraphs (a), (c) and (d) of the Agreement should be amended to read "the 1st of December, 1962".
- I have the honour to propose further that in the period ending the 1st of December, 1962, Turkish liras from the account in question will be freely accepted for purchases of the Turkish products listed in the Annex to this letter, or for other products which may be approved by the Turkish Government and officially notified by them to Her Majesty's Embassy. intended for internal consumption in the United Kingdom and effected by traders resident in the United Kingdom up to a total amount of 13.3 million Turkish liras.
- 4. If the foregoing proposals are acceptable to the Government of the Republic of Turkey, I have the honour to suggest that this Note, together with its Annex, and Your Excellency's reply to that effect should constitute an Agreement between the two Governments in this matter.

Türkçe tercümesi aşağıda dercolunan 23 Haziran 1962 tarihli mektuplarının alındığını Ekselânslarına bildirmekle şeref duyarım.

- "1. Büyük Britanya ve Kuzey Irlanda Hükûmeti ile Türkiye Cümhuriyeti Hükûmeti arasında 1 Haziran 1961 tarihinde nihayet bulacak devre için Ankarada 9 Aralık 1960 tarihinde Nota teatisi suretiyle aktedilmiş olan ve 11 Şubat 1954 tarihli Anlaşma ile alâkalı mali hususlara müteallik bulunan ve 31 Mayıs ve 30 Kasım 1961 tarihlerinde sırası ile 1 Aralık 1961 ve 1 Haziran 1962 ye kadar temdit edilen Anlaşmaya rücu etmekle şeref duyarım.
- 2. İngiltere Hükûmeti Dışişleri Bakanından aldığim talimat gereğince sözü edilen Anlaşmanın 1 Haziran 1962 tarihinden 1 Aralık 1962 tarihine kadar yeniden uzatılmasını ve bu maksatla Anlaşmanın (a), (c) ve (d) fikralarındaki "1 Haziran 1962" tarihinin "1 Aralık 1962" olarak değiştirilmesini teklif etmekle şeref duyarim.
- 3. Ayrıca 1 Aralık 1962 de sona erecek olan devre zarfında bu mektuba bağlı listedeki veya Türk Hükûmeti tarafından kabul olunup Majestelerinin Büyük Elçiliğine resmen tebliğ edilecek diğer Türk mallarının İngilterede mukim tüccarlar tarafından İngiltere dahilinde istihlâk edilmek üzere mübayaasında, söz konusu hesaptaki Türk Liralarından 13,3 milyon T. Lirasına kadar olan kısmının serbestçe kullanılmasını teklif etmekle şeref duyarım.

4. Yukarıdaki teklif Türkiye Cümhuriyeti Hükûmeti tarafından kabule şayan görüldüğü taktirde, bu Nota ve eki liste ve Zatı Alilerinin bu husustaki cevabının iki Hükûmet arasında bu mevzuda varılmiş bir Anlaşma telâkki edilmesini teklif etmekle şeref duyarım."

Türkiye Cümhuriyeti Hükûmetinin yukarıdaki hususlarda mutabık olduğunu Ekselânslarına arzetmekle şeref duyarım.
