The Laotian Prime Minister to Her Majesty's Ambassador at Vientiane

Excellence,

### Vientiane, le 24 Décembre 1963.

Le plan de stabilisation de l'économie, nécessite que certaines rectifications soient apportées à la procédure d'utilisation de l'aide commercialisée que votre Gouvernement a accordée à mon Pays par la Convention du 17 Mai 1963.

J'ai l'honneur, en conséquence, de vous faire les propositions suivantes :

(1) La dernière phrase du paragraphe 2 de l'annexe B de la Convention susvisée doit être supprimée.

(2) Le montant du cautionnement prévu au paragraphe 3 de la même annexe: lire 20% au lieu de 50%.

Si le Gouvernement du Royaume-Uni de la Grande-Bretagne et de l'Irlande du Nord donne son accord à ces propositions, j'ai l'honneur de suggérer que la présente, avec votre lettre d'accord, seront considérées comme une Convention entre nos deux Gouvernements.

#### Translation of No. 1

Excellency,

Vientiane, December 24, 1963.

The programme to stabilise the economy, requires some amendments to the procedure for using the commercial aid which your Government has granted to my country by the Agreement of the 17th of May, 1963.<sup>(1)</sup>

I have the honour, therefore, to make the following proposals:

(1) The last sentence of paragraph 2 of Annex B of the Agreement referred to above should be deleted.

(2) The amount of the guarantee deposit envisaged in paragraph 3 of the same annex: read 20% instead of 50%.
