British Embassy,

Your Excellency,

Amman, March 7, 1963.

I have the honour to refer to the Agreement constituted by the Exchange of Notes of the 25th/30th of May, 1962,(1) between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of the Hashemite Kingdom of Jordan, as modified by the further Exchange of Notes of the 11th/15th of September, 1962,(2) concerning the interest free loan which has been made by the Government of the United Kingdom of Great Britain and Northern Ireland to the Government of the Hashemite Kingdom of Jordan during the financial year ending the 31st of March, 1963. Acting upon instructions from Her Majesty's Principal Secretary of State for Foreign Affairs, I now have the honour to propose to Your Excellency the following further, allocation of money from the loan:

(A) 1. Development of Water Resources:

(B) The allocation under paragraph (D) of the Exchange of Notes of the 25th/30th of May will be cancelled, and the balance of the sum allocated in last year's development loan for the Jerusalem and District Water Supply will be added to the sum allocated at (A) 1 (b) in this Note for additional work in connexion with this project.

(C) The allocations under paragraphs 3, 4 and 6 of the Exchange of Notes of the 11th/15th of September for the purchase of pedigree cattle, for the purchase of two mobile dispensaries, and for a survey of copper deposits will also be cancelled.

If the foregoing allocation is acceptable to the Government of the Hashemite Kingdom of Jordan, I have the honour to suggest that the present Note and Your Excellency's reply in that sense should be regarded as constituting an agreement between the two Governments in this matter.
