EXCHANGE OF NOTES BETWEEN THE GOVERNMENT OF THE UNITED KINGDOM OF GREAT BRITAIN AND NORTHERN IRELAND AND THE GOVERNMENT OF THE REPUBLIC OF AGREEMENT CONCERNING TURKEY **AMENDING** THE ARRANGEMENTS CONSTITUTED FINANCIAL **EXCHANGE OF NOTES OF DECEMBER 9. 1960**

Monsieur le Ministre.

Ankara, June 17, 1963.

I have the honour to refer to the Agreement between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of the Republic of Turkey concerning Financial Arrangements for the period ending the 1st of June, 1961, relating to the Agreement of the 11th February, 1954.(1) which was constituted by Notes exchanged at Ankara on the 9th of December, 1960,(2) and to the Agreed Minutes of the 31st of May,(3) and the 30th of November, 1961,(4) which extended the said Agreement to the 1st of December, 1961, and the 1st of June, 1962, respectively, and to the exchange of Notes on the 23rd of June, 1962,(5) and on the 27th of December, 1962,(6) which extended the said Agreement to the 1st of December, 1962, and to the 1st of June, 1963 respectively.

- Acting upon instructions from Her Majesty's Principal Secretary of State for Foreign Affairs, I now have the honour to propose that the said Agreement should be further extended from the 1st of June, 1963 until the 1st of December 1963, and that for this purpose the date "the 1st of June, 1963" in paragraphs (a), (c) and (d) of the Agreement should be amended to read "the 1st of December, 1963".
- 3. I have the honour to propose further that in the period ending the 1st of December, 1963, Turkish liras from the account in question will be freely accepted for purchases of the Turkish products listed in the Annex to this letter, or for other products which may be approved by the Turkish Government and officially notified by them to Her Majesty's Embassy. intended for internal consumption in the United Kingdom and effected by traders resident in the United Kingdom up to a total amount of approximately 5.5 million Turkish liras.

- 4. The 1961 crop seedless raisins listed in the Annex may be purchased by traders resident in the United Kingdom exclusively for consumption in Japan and Canada.
- 5. If the foregoing proposals are acceptable to the Government of the Republic of Turkey, I have the honour to suggest that this Note, together with its Annex, and your Excellency's reply to that effect should constitute an Agreement between the two Governments in this matter.

Türkçe tercümesi aşağıya dercolunan 17 Haziran 1963 tarihli mektuplarının alındığını Ekselanslarına bildirmekle şeref duyarım:

- "1. Büyük Britanya ve Kuzey İrlanda Hükûmeti ile Türkiye Cumhuriyeti Hükûmeti arasında 1 Haziran 1961 tarahinde nihayet bulacak devre için Ankara'da 9 Aralık 1960 tarihinde Nota teatisi suretiyle akdedilmiş olan ve 11 Şubat 1954 tarihli Anlaşma ile alâkalı malî hususlara müteallik bulunan ve 31 Mayıs ve 30 Kasım 1961 tarihlerinde sırasiyle 1 Aralık 1961 ve 1 Haziran 1962 ye kadar temdit edilen Anlaşmaya ve mezkûr Anlaşmayı sırasıyle 1 Aralık 1962 ve 1 Haziran 1963 e kadar temdit eden 23 Haziran 1962 ve 27 Aralık 1962 tarihlerindeki Nota teatisine rücû etmekle şeref duyarım.
- 2. Birleşik Kırallık Hükûmeti Dışişleri Bakanından aldığım talimat gereğince sözü edilen Anlaşmanın 1 Haziran 1963 tarihinden 1 Aralık 1963 tarihine kadar yeniden uzatılmasını ve bu maksatla Anlaşmanın (a), (c) ve (d) fıkralarındaki "1 Haziran 1963" tarihinin "1 Aralık 1963" olarak değiştirilmesini teklif etmekle şeref duyarım.
- 3. Ayrıca, 1 Aralık 1963 de sona erecek devre zarfında bu mektuba bağlı listedeki veya Türk Hükûmeti tarafından kabul olunup Majestelerinin Büyükelçiliğine resmen tabliğ edilecek diğer Türk mallarının Birleşik Kırallıkta mukim Tüccarlar tarafından Birleşik Kırallık dahilinde istihlâk edilmek üzere mübayaasında, söz konusu hesaptaki Türk liralarından takriben 5,5 milyon Türk lirasına kadar olan kısmının serbestçe kullanılmasını teklif etmekle şeref duyarım.
- 4. Ek listede kayıtlı mallardan 1961 mahsulü çekirdeksiz kuru üzüm, Birleşik Kırallık dahilinde mukim tüccarlar tarafından münhasıran Japonya ve Kanada'da istihlâk edilmek üzere mübayaa edilebilir.
- 5. Yukarıdaki teklifler Türkiye Cumhuriyeti Hükûmeti tarafından kabule şayan görüldüğü takdirde, bu Nota ve eki liste ve Zatı Alilerinin bu husustaki cevabının iki Hükûmet arasında bu mevzuda varılmış bir Anlaşma telâkki edilmesini teklif etmekle şeref duyarım."

Türkiye Cumhuriyeti Hükûmetinin yukarıdaki hususlarda mutabık olduğunu Ekselânslarına arzetmekle şeref duyarım.
