

Your Excellency,

I have the honour to refer to our recent discussion about Jordan's present financial situation and to propose that the arrangements agreed upon in paragraph 1 (c) of the Agreement constituted by the Exchange of Notes of the 24th and 26th of March, 1958(1) concerning a loan by the Government of the United Kingdom of Great Britain and Northern Ireland to the Government of the Hashemite Kingdom of Jordan, should be modified in such a way that repayment of the instalment of £50,000 sterling which was due on the 1st of April, 1963, should be deferred until the 1st of April, 1969.

If the foregoing proposal is acceptable to the Government of the United Kingdom of Great Britain and Northern Ireland, I request that the present Note and Your Excellency's reply in that sense should be regarded as constituting an Agreement between the two Governments in this matter.



I have the honour to refer to our recent discussion about Jordan's present financial situation and to propose that the arrangements agreed upon in paragraph 1 (b) of the Annex to the Agreement constituted by the Exchange of Notes of the 13th of March, 1957,(2) and terminating the Treaty of Alliance of the 15th of March, 1948,(3) between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of the Hashemite Kingdom of Jordan, as modified by the Agreements constituted by the Exchanges of Notes of the 26th of April, 1958,(4) the 7th of September, 1959,(5) the 2nd of June, 1960,(6) the 8th of June, 1961,(7) and the 19th of March, 1963,(*) between the two Governments, should be further modified in such a way that payment of the instalment of £500,000 sterling which was due on the 1st of May, 1963, should be deferred until the 1st of May, 1969.

If the foregoing proposal is acceptable to the Government of the United Kingdom of Great Britain and Northern Ireland I have the honour to suggest that the present Note and your Excellency's reply in that sense should be regarded as constituting an Agreement between the two Governments in this matter.
