*Buenos Aires, 22 October 1968.*

Your Excellency,

I have the honour to refer to this Embassy's Note No. 214 of 2 July 1968 which informed Your Excellency that the authorities of the Isle of Man have decided to issue their own passports.

2. The Government of the United Kingdom wish to apply to the holders of the said passports the Agreement between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of the Argentine Republic for the abolition of Visas constituted by the Exchange of Notes of 17 February 1967<sup>(1)</sup>.

3. I now have the honour to propose, on the instructions of Her Majesty's Principal Secretary of State for Foreign Affairs, that the words "or Isle of Man" be inserted after the words "Guernsey or its Dependencies" in subparagraph 1 (a) of the said Agreement.

4. If the foregoing proposal is acceptable to the Government of the Argentine Republic, I have the honour to suggest that this Note together with Your Excellency's reply to that effect shall constitute an Agreement between the two Governments in this matter.

I avail myself of this opportunity to renew to Your Excellency the assurance of my highest consideration.

El Gobierno del Reino Unido desearía hacer extensivas a los poseedores de dichos pasaportes las disposiciones del Convenio entre el Gobierno del Reino Unido e Irlanda del Norte y el Gobierno de la República Argentina sobre la abolición de las visas constituido por las notas reversales del 17 de febrero de 1967.

3. Por la presente tengo el honor de proponer, en cumplimiento de instrucciones impartidas por el Secretario Principal de Estado para Asuntos Exteriores de Su Majestad, que las palabras "or Isle of Man" sean insertadas a continuación de las palabras "Guernsey or its Dependencies" en el inciso 1 (a) de dicho Convenio.

4. De merecer la aprobación del Gobierno de la República Argentina esta propuesta, tengo el honor de sugerir que la presente Nota, juntamente con la contestación de Vuestra Excelencia en ese sentido constituyan un Convenio entre ambos Gobiernos sobre la materia."

Al respecto, me complazco en informarle que la propuesta que antecede es aceptada por el Gobierno de la República Argentina el que, en consecuencia, expresa su conformidad de que la Nota de Vuestra Excelencia juntamente con la presente contestación contituyan un Convenio entre ambos Gobiernos sobre la materia.
