Her Majesty's Ambassador at Santo Domingo to the Dominican Secretary of State for Foreign Affairs

> British Embassy, Santo Domingo, 26 June, 1968.

Your Excellency,

I have the honour to refer to this Embassy's Note No. 31 of 25 June 1968 which informed Your Excellency that the authorities of the Isle of Man have decided to issue their own passports.

- 2. The Government of the United Kingdom wish to apply to the holders of the said passports the Agreement between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of the Dominican Republic for the Abolition of Visas constituted by the Exchange of Notes of the 20th of June of 1967.(1)
- 3. I now have the honour to propose, on the instructions of Her Majesty's Principal Secretary of State for Foreign Affairs, that the words "or Isle of Man" be inserted after the words "Guernsey or its Dependencies" in paragraph (2) of the said Agreements.
- 4. If the foregoing proposal is acceptable to the Government of the Dominican Republic, I have the honour to suggest that this Note together with Your Excellency's reply to that effect shall constitute an Agreement between the two Governments in this matter.

I avail myself of this opportunity to renew to Your Excellency the assurance of my highest consideration.

Señor Embajador:

Tengo a honra avisar recibo de la atenta Nota de fecha 26 de junio de 1968, en adición a la No. 31 del mismo mes y año, mediante la cual me expresa que el Gobierno del Reino Uni do desea hacer extensivo el régimen sobre pasaportes contenido en el Acuerdo existente entre el Gobierno del Reino Unido de la Gran Bretaña e Irlanda del Norte y el Gobierno de la República Dominicana para suprimir las visas, el cual quedó terminado mediante el intercambio de Notas del 20 de junio de 1967.

Propone Vuestra Excelencia de acuerdo con las instrucciones del Primer Secretario de Estado de Relaciones Exteriores de Su Majestad que la frase "o Isla de Man" sea insertada después de las palabras "Guernsey o sus Dependencias" en el párrafo (2) de dicho Acuerdo.

En respuesta, me complazco en llevar a conocimiento de Vuestra Excelencia que el Gobierno Dominicano está de acuerdo con incorporar al Convenio citado la frase transcrita en esta Nota, por lo cual este intercambio constituye un Acuerdo entre los dos Gobiernos respecto de este asunto.

I have the honour to acknowledge receipt of your Note of the 26th of June, 1968, in addition to Note No. 31 of the same month and year, in which you informed me that the Government of the United Kingdom wish to extend the provisions on passports contained in the existing Agreement between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of the Dominican Republic to abolish visas, concluded by the Exchange of Notes of the 20th of June, 1967.

Your Excellency proposes, in accordance with the instructions of Her Majesty's Principal Secretary of State for Foreign Affairs that the phrase "or Isle of Man" be inserted after the words "Guernsey or its Dependencies" in paragraph (2) of the said Agreement.

In reply, I am pleased to inform Your Excellency that the Dominican Government agree to incorporate in the said Agreement the phrase mentioned in this Note, for which purpose this exchange shall constitute an Agreement between the two Governments in this matter.

I avail myself of this opportunity to renew to Your Excellency the assurance of my highest consideration.
