### EXCHANGE OF NOTES

BETWEEN THE GOVERNMENT OF THE UNITED KINGDOM OF GREAT BRITAIN AND NORTHERN IRELAND AND THE UNITED NATIONS DEVELOPMENT PROGRAMME APPLYING TO THE UNITED NATIONS DEVELOPMENT PROGRAMME THE AGREEMENT OF 27 JUNE 1963 BETWEEN THE UNITED KINGDOM AND THE UNITED NATIONS FOR THE PROVISION OF OPERATIONAL AND EXECUTIVE PERSONNEL TO OVERSEAS TERRITORIES OF THE UNITED KINGDOM

> United Kingdom Mission to the United Nations, New York. 1 April, 1971.

Sir,

With reference to discussions between this Mission and the United Nations Development Programme (UNDP) concerning requests for Operational Assistance which might be received by the UNDP from Trust, Non-Self-Governing and other Territories for the conduct of whose international relations the Government of the United Kingdom of Great Britain and Northern Ireland are responsible, I have the honour, in accordance with instructions received from the Government of the United Kingdom, to confirm to you their acceptance that the Agreement for the Provision of Operational and Executive Personnel between the United Kingdom and the United Nations signed on the 27th of June, 1963,(1) will apply to any Operational Officer who might be appointed by any of the Participating and Executing Agencies of the UNDP in response to such requests.

It is further agreed that in accordance with the provisions of paragraph 6 of Economic and Social Council Resolution 951 (XXXVI), the Governments of such Territories will contribute to the cost of providing any Operational Officer by paying the Officer the salary, allowances and other related emoluments which would be payable to a national civil servant or other comparable employee holding the same rank to which the Officer is assimilated. Should the total emoluments forming the Government's contribution in respect of the Officer amount to less than twelve and one-half per cent of the total cost to the Participating and Executing Agency of providing that Officer, however, the Government of the Territory concerned would make an additional payment to the UNDP in an amount which would bring the Government's total contribution for the Officer, such payment to be made annually in advance.

It is further agreed that the foregoing arrangements shall not apply to any Associated State unless they are extended to that State by notification given by the Government of the United Kingdom to the Administrator of the UNDP.

I should be grateful for confirmation from you that these arrangements are acceptable to the UNDP. If you so confirm, I suggest that this letter and your reply should be regarded as constituting an agreement between the Government of the United Kingdom, on the one hand, and the UNDP and its Participating and Executing Agencies, on the other hand, with respect to this matter.
