## **EXCHANGE OF NOTES**

BETWEEN THE GOVERNMENT OF THE UNITED KINGDOM OF GREAT BRITAIN AND NORTHERN IRELAND AND THE GOVERNMENT OF THE REPUBLIC OF SOUTH AFRICA FURTHER AMENDING THE AGREEMENT ON THE ESTABLISHMENT OF CIVIL AIR SERVICES SIGNED AT PRETORIA ON 26 OCTOBER 1945

Note No. 23 Your Excellency,

I have the honour to refer to the Agreement between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of the Union of South Africa in connection with the establishment of Civil Air Services between the United Kingdom and the Union, of 26 October 1945,(1) as amended by the Exchanges of Notes of 15 September 1959(2) and of 1 December 1972,(3) and to propose that the term "British Airways" be substituted for the terms "British Overseas Airways Corporation" and "BOAC" throughout the Agreement (including its annex) and the amendments.

If the above proposal is acceptable to the Government of the Republic of South Africa I have the honour to propose that this Note and your reply to that effect shall be regarded as constituting an Agreement between our two Governments in this matter which shall enter into force on this day's date.

Please accept, Your Excellency, the assurance of my highest consideration.
