#### DECISION

# OF THE REPRESENTATIVES OF THE GOVERNMENTS OF THE MEMBER STATES OF THE EUROPEAN COAL AND STEEL COMMUNITY, MEETING WITHIN THE COUNCIL, ALLOCATING TO THAT COMMUNITY SUPPLEMENTARY REVENUES FOR 1978

The Representatives of the Governments of the Member States of the European Coal and Steel Community, meeting within the Council,

Whereas, in the present situation of the coal and steel industry, the financial means at the Commission's disposal to accomplish its task under the Treaty establishing the European Coal and Steel Community<sup>(1)</sup> must be increased; whereas the Member States should accordingly allocate to it supplementary revenues under that heading;

Whereas it is appropriate, by way of exception, to allocate such revenues to the European Coal and Steel Community for the financial year 1978 to enable it to balance its revenues and expenditure,

In agreement with the Commission,

Have decided as follows:

#### ARTICLE 1

Member States shall pay to the European Coal and Steel Community the sum of 28 million EUA for the financial year 1978 as an exceptional contribution.

#### ARTICLE 2

The contributions to be made by the Member States shall be:

#### ARTICLE 3

The sums to be paid by each Member State shall be payable on 1 December 1978.

The payments may be made either in EUA or in national currencies at the EUA exchange rate on the day of payment.

#### ARTICLE 4

The Member States shall, in close co-operation with the Commission, take all necessary measures to ensure the application of the aforegoing provisions.

#### ARTICLE 5

The Member States shall take the provisions necessary to implement this Decision.
