I have the honour to refer to the Agreement between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of Malaysia for Air Services between and beyond their respective territories signed at London on 24 May 1973(1), and to discussions which took place at London from 17-20 July 1979 between the aeronautical authorities of the two Governments. During these discussions, it was agreed in principle that the revised route schedules set out in the Annex to this Note should be substituted for those contained in the Annex to the said Agreement.

I now have the honour, in accordance with Article 12 of the Agreement, to inform Your Excellency that the revised route schedules are acceptable to the Government of the United Kingdom and, if they are also acceptable to the Government of Malaysia, to propose that this Note with its Annex, and Your Excellency's reply in that sense, should constitute an Agreement between the two Governments in this matter which shall enter into force on the date of Your Excellency's reply.

I avail myself of this opportunity to renew to Your Excellency the assurance of my highest consideration.

I have the honour to refer to Your Excellency's Note dated 9th October, 1979, regarding the Agreement between the Government of Malaysia and the Government of the United Kingdom of Great Britain and Northern Ireland for Air Services between and beyond their respective territories of 1973 and to discussions which took place at London from 17–20 July, 1979 between the aeronautical authorities of the two Governments.

In this connection, I have the honour to inform Your Excellency that the revised route schedules set out in the Annex to the aforementioned Note that was agreed to in principle during the discussions which took place in London from 17-20 July, 1979 are acceptable to the Government of Malaysia. I hereby confirm that this Note in reply, and Your Excellency's Note with its Annex, would constitute an Agreement between the two Governments in this matter, and that this Agreement shall enter into force as from this day's date.
