Your Excellency

1. I have the honour to refer to the United Kingdom/Jordan Development Loan 1973/1976, constituted by Notes exchanged at Amman on 11 and 14 June 1973⁽¹⁾ and on 20 March and 3 April 1976⁽²⁾, (hereinafter referred to as "the Development Loan 1973/1976"), and to discussions between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of the Hashemite Kingdom of Jordan concerning the allocation of additional funds to meet the increased costs of establishing a national electricity grid in Jordan.

2. It is the intention of the Government of the United Kingdom to make available to the Government of Jordan an additional sum not exceeding £131,000 (one hundred and thirty one thousand pounds sterling), which sum shall be subject to the same arrangements and procedures as those specified in the Development Loan 1973/1976, as amended in paragraph (3) below.

3. To take account of this additional sum, the repayment schedule in paragraph B (10) of the Development Loan 1973/1976 (as amended by paragraph (3) of the Notes exchanged at Amman on 20 March and 3 April 1976) shall be further amended to read:

14 December 1980 and on 14 December in each of the succeeding 17 years	301,000
14 June 1981 and on 14 June in each of the succeeding 16 years	301,000
14 June 1998	297,000

4. If the foregoing is acceptable to the Government of the Hashemite Kingdom of Jordan, I have the honour to propose that this Note, together with Your Excellency's reply in that sense, shall constitute an Agreement

between our two Governments which shall enter into force on the date of Your Excellency's reply. This Agreement, together with the Development Loan 1973/1976, shall be referred to as the United Kingdom/Jordan Development Loan 1973/1979.

I avail myself of this opportunity to renew to Your Excellency the assurance of my highest consideration.
