Her Majesty's Ambassador at Copenhagen to the Minister without Portfolio of Denmark

Your Excellency,

I have the honour to refer to the Treaty between the United Kingdom and Denmark for the Mutual Surrender of Fugitive Criminals signed at Copenhagen on 31 March 1873(1), as amended by the supplementary Convention signed at Copenhagen on 15 October 1935(2).

I have to propose on behalf of the Government of the United Kingdom of Great Britain and Northern Ireland that Article XII of the Treaty of 1873 shall be amended to read as follows:

- "(1) Expenses incurred in the territory of the requested Party by reason of the request for extradition shall be borne by that Party.
- (2) The requested Party shall make all arrangements which may be requisite with respect to the representation of the requesting Party in any proceedings arising out of the request."

If the foregoing proposal is acceptable to the Government of the Kingdom of Denmark, I have the honour to suggest that this Note, together with Your Excellency's reply to that effect, shall constitute an Agreement between the two Governments which shall enter into force three months from the date of your reply.

I avail myself of this opportunity to renew to Your Excellency the assurance of my highest consideration.

# The Minister without Portfolio of Denmark to Her Majesty's Ambassador at Copenhagen

København, den 24. august 1979.

Deres Excellence.

Jeg har den ære at enerkende modtagelsen af Deres Excellences note, dateret i dag, der i oversættelse lyder:

"Deres Excellence,

Jeg har den ære at henvise til den mellem Det Forenede Kongerige og Kongeriget Danmark indgåede traktat af 31. marts 1873 om gensidig udlevering af flygtede forbrydere, som ændret ved tillægsoverenskomsten underskrevet den 15. oktober 1935.

På Det Forenede Kongerige Storbritannien og Nord-Irlands regerings vegne skal jeg foreslå, at artikel XII i traktaten af 1873 ændres til at lyde som følger:

- (1) Udgifter, der opstår i den begærede parts territorium som følge af en begæring om udlevering, skal afholdes af denne part.
- (2) Den begærede part skal træffe alle nødvendige foranstaltninger for den begærede parts repræsentation under en hvilken som helst retslig handling, der opstår som følge af begæringen.

Såfremt dette forslag kan godtages af Kongeriget Dammarks regering, har jeg den ære at foreslå, at denne note tillige med Deres Excellences bekræftende svar skal udgøre en aftale mellem de to regeringer, der skal træde i kraft efter tre måneder fra datoen for Deres svar.

Modtag på ny, Deres Excellence, forsikringen om min mest udmærkede højagtelse."

I besvarelse har jeg den ære at meddele Deres Excellence, at de foranstående forslag kan godtages af Kongeriget Danmarks regering, der derfor er enig i, at Deres note og dette svar skal udgøre en aftale mellem de to regeringer, og at aftalen skal træde i kraft tre måneder fra i dag.

Modtag på ny, Deres Excellence, forsikringen om min mest udmærkede højagtelse.
