### The United Kingdom High Commissioner at Banjul to the Secretary General, President's Office of The Gambia

British High Commission Banjul 30 March 1981

Sir,

I have the honour to refer to the British Expatriates Supplementation (The Gambia) Agreement 1976(<sup>1</sup>), as amended(<sup>2</sup>), (hereinafter referred to as "the Agreement") and to propose that the Agreement be further amended as follows:

- (a) in paragraph 3, delete the words and figures "31 March 1981" and substitute thereafter the words and figures "31 March 1986";
- (b) in the First Annex delete St. Joseph's School;
- (c) in paragraph 2 of the Second Annex, delete subparagraph (d).

If these proposals are acceptable to the Government of the Republic of The Gambia, I have the honour to suggest that this Note and your reply shall constitute an agreement between our two Governments which shall enter into force on 31 March 1981 and which shall be cited, together with the Agreement, as the British Expatriates Supplementation (The Gambia) Agreement 1976/81.
