Sir,

I have the honour to refer to the Overseas Service (Botswana) Continuance Agreement 1970/76<sup>(1)</sup> (hereinafter referred to as "the agreement") and to propose that the agreement be amended as follows.

- (a) Sub-paragraph 5(d) of paragraph 1 is deleted; and sub-paragraph 5(e) becomes sub-paragraph 5(d);
- (b) In sub-paragraphs 7 and 8 of paragraph 1, delete the punctuation and the word "gratuity";
- (c) In sub-paragraph 14 of paragraph 1, delete the words and figures "31 March 1981" and substitute therefor the words and figures "31 March 1986".

If these proposals are acceptable to the Government of Botswana, I have the honour to suggest that this note and your reply shall constitute an agreement between our two governments which shall enter into force on 31 March 1981 and which shall be cited, together with the agreement, as the Overseas Service (Botswana) Agreement 1970/81.
