## The Swiss Ambassador at London to the Secretary of State for Foreign and Commonwealth Affairs

#### 571.45

The Swiss Ambassador presents his compliments to Her Majesty's Principal Secretary of State for Foreign and Commonwealth Affairs and, with reference to the air services consultations held in Berne on 13th and 14th December 1982 between the aeronautical authorities of Switzerland and the United Kingdom with a view to modifying the route schedules of the Agreement between the Swiss Federal Council and the Government of the United Kingdom for Air Services between and beyond their Territories of 5th April 1950<sup>(1)</sup>, has the honour to propose, under article 9 of the said agreement, the following amendments:

#### SCHEDULE I

Routes to be served by the designated airlines of Switzerland :

Route 3

For "Tokyo" substitute "Manila-Seoul-Tokyo".

#### SCHEDULE II

Routes to be served by the designated airlines of the United Kingdom :

#### Route 3

Substitute:

3 "Points in the United Kingdom—Zurich or Geneva—a point in Turkey—Tel Aviv or Beirut or Damascus or Cairo—a point in Iraq—Kuwait—Bahrain or Doha or Dubai or Abu Dhabi or Muscat—a point in Iran—a point in Pakistan—points in India— Dhaka—Rangoon—Bangkok—Kuala Lumpur—Singapore—Brunei —Hong Kong—Peking—Seoul—Manila—Osaka—Tokyo—Jakarta —Port Moresby—points in Australia—points in New Zealand".

#### Route 4

For "points in Rhodesia" substitute "points in Zimbabwe".

Add Route 5:

5 "Hong Kong-Bangkok-Kuala Lumpur-a point in India or Pakistan or Sri Lanka-a point in the United Arab Emirates or Bahrain-Frankfurt-Paris-a point in Switzerland-Paris-Frankfurt."
