# AGREEMENT TERMINATING THE COMMONWEALTH TELECOMMUNICATIONS ORGANISATION FINANCIAL AGREEMENT, 1973

The Governments signatories to this Agreement;

Being Partner Governments to the Commonwealth Telecommunications Organisation Financial Agreement 1973(1);

Agree as follows:

#### ARTICLE 1

This Agreement, upon entry into force, shall terminate the Commonwealth Telecommunications Organisation Financial Agreement 1973.

#### ARTICLE 2

Where settlements in respect of the period from 1 April 1973 until the entry into force of this Agreement have not been made under the Commonwealth Telecommunications Organisation Financial Agreement 1973, data shall, if not already prepared, be prepared by the National Bodies of the Governments signatories to this Agreement as soon as possible and the ensuing settlements be made between them, both actions as nearly as possible in accordance with the Commonwealth Telecommunications Organisation Financial Agreement 1973.

#### ARTICLE 3

By their signature of this Agreement the Governments signatories hereto accept it on their own behalf and on behalf of their National Bodies and in respect of the territories for the international relations of which any such Government is responsible.

#### ARTICLE 4

This Agreement shall enter into force on 1 April 1983.

In witness whereof the undersigned, being duly authorised thereto by their respective Governments, have signed this Agreement on the dates appearing opposite their signatures.

Done at London in a single-original which shall be deposited in the archives of the Government of the United Kingdom of Great Britain and Northern Ireland, which shall transmit certified copies thereof to all signatory Governments and to the Commonwealth Secretary-General.
