# OF GREAT BRITAIN AND NORTHERN IRELAND AND THE GOVERNMENT OF THE REPUBLIC OF FINLAND AMENDING THE AGREEMENT ON INTERNATIONAL ROAD TRANSPORT SIGNED AT HELSINKI ON 8 APRIL 1975

#### No. 1

Her Majesty's Ambassador at Helsinki to the Secretary of State, Ministry for Foreign Affairs of Finland

> British Embassy, Helsinki 18 December 1985

Your Excellency,

I have the honour to refer to the Agreement between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of the Republic of Finland on International Road Transport, signed at Helsinki on 8 April 1975(1) (hereinafter referred to as "the Agreement") and to propose:

- (i) that the text of Article 1(d) of the Agreement shall be replaced by the following: "(d) in relation to the United Kingdom, the term 'territory' shall mean England, Wales, Scotland, Northern Ireland and Gibraltar"; and
- (ii) that on and after 1 January 1985 a permit shall not be, and shall not have been required in order to engage in the transport operations referred to in Article 5 of the Agreement, and that accordingly in relation to such transport operations carried out on and after that date the Agreement shall have effect as if Article 6, 7 and 12, and the words "in addition to any permit required under Article 6" in Article 10, were deleted.

If the foregoing proposals are acceptable to the Government of the Republic of Finland, I have the honour to suggest that the present Note and Your Excellency's reply to that effect shall constitute an Agreement between our two Governments which shall enter into force on the date of Your Excellency's Reply.(2)

I avail myself of this opportunity to renew to Your Excellency the assurance of my highest consideration.
